The Juries (Rifle, Pistol RTS and Equipment Control Jury) will be designated by the ESC to supervise the Championship. Qualified Range Officers holding applicable ISSF Licenses will conduct the competitions.

#### Rifle / Pistol Equipment

Equipment Control will be conducted according to ISSF Rules using approved, calibrated instruments. All athletes are urged to submit any doubtful equipment and clothing to Equipment Control for checking before the competition. All athletes are subject to being selected for random post-competition testing and will be disqualified if their equipment or clothing is not legal according to ISSF Rules.

#### Rifle Clothing

All rifle athletes must have ISSF seals with serial numbers on their jackets and trousers. Any rifle jackets or trousers that do not have ISSF seals must be submitted to Equipment Control for inspection. Rifle athletes can have only one active jacket and trousers at any time. No new seal will be added during the European championship.

#### All Post-Competition Testing

All post competition testing will be done according to the ISSF Rules.

## 4. PARTICIPATION

#### ISSF/ESC Events

##### Individual

ESC Member Federations may enter a maximum of five (5) athletes in the individual events.

A maximum of three (3) athletes of one nation entered in 10m Air Rifle, 10m Air Pistol individual events can be registered to compete in the Final for the medals. Two (2) other athletes entered in individual events can compete for ranking points only (RPO). The RPO athletes cannot neither proceed to the Final nor establish records.

##### Team (as per ISSF rules)

Only 3 athletes from the same age category and gender can be registered as a team, and they must be officially declared at the accreditation office as per ISSF rules. Only 1 team per MF is allowed. All athletes must be in competition. RPO Athletes cannot be part of the team.

##### Mixed Team events

ESC Member Federations may enter a maximum of two (2) teams.

## ESC Challenge events

### Solo

ESC Member Federations may enter a maximum of five (5) athletes in the Solo events. A maximum of three (3) athletes of one nation (the three top- ranked after Qualification part 1) may proceed to the Qualification part 2.

### Trio

ESC Member Federations may enter only 1 Trio. The registration of the athletes in the Trio Events (each trio will be composed of three (3) members). The Trio must be composed of participants of the respective Solo events. The Trio must be declared at the accreditation office at the arrival.

### Maximum Entry

The maximum number of starts per event is the number of athletes that can be accepted for each European Championship event depending on the Range capacity that is determined by the available shooting time and the number of available firing points.

If the maximum number of starts is reached during the Final Entry process, ESC and the Organizing Committee will (cooperate to determine if additional entries can be accommodated) try to accommodate all remaining entries, if possible.

## 5. ENTRY PROCESS

Preliminary and Final Entries for Athletes and Officials must be done directly online at the link: <https://shootingssportscloud.com>.

All other Registration Forms must be returned to the Organizing Committee (see also: "Summary of Deadlines").

### Preliminary Entries

ESC Member Federations entering the Championships must submit the Preliminary Entries not later than **31 DEC 2024**.

### Final Entries

ESC Member Federations must forward their Final Entries directly to the ISSF HQ. The Final Entry Deadline (30 days before the Official Arrival Day) is **05 FEB 2025**.

### Late Entries

If the maximum number of athlete entries have not been reached, late entries will only be accepted until the Late Entry Deadline (3) days before the official arrival day.

Late Entry Deadline is 03.03.2025, from 04.03.2025 onwards the system is closed.

**Important Note:** Until the 3 days Late Entry Deadline, the following changes in the Final Entries are possible without restriction and additional fees:

- a) Change of names / athletes within an event
- b) Change of Status (ECH athlete ↔ "RPO only" athlete) within an event.

### Entry Confirmation upon arrival

All Team Leaders of ESC Member Federation Delegations must report to the OC Entries Official and confirm their Final Entries. The confirmation must be completed before 12:00h on the day before the Pre-Event Training.

### Entry Changes after the Late Entry Deadline

From days before the start of each event onwards, only the following changes in the Final Entries are permitted:

- a) Replacement of a registered athlete by another already registered athlete in another event can be made only before 12:00h on the day before the Pre-Event Training for that event.
- b) Change of Status between "ECH athlete" and "RPO only athlete" can be made only before 12:00 on the day before the Pre-Event Training for that event

### Cancellation

Any ESC Member Federation that reduces the number of athletes listed in their Final Entries after the Final Entry Deadline (**06 FEB 2025**) must pay applicable entry fees and hotel room cancellation costs according to the number of athletes and entries on the Final Entry Forms originally received. If the applicable fees and costs are not paid, no member of that federation may participate.

### Entry Fee

The entry fees include all charges for registration, local transportation between shooting range and official hotels and doping control.

**\* All entry fees for the Solo, Duets and Trios events will be paid to the Organizing Committee by the ESC Sponsorship.**

**For the Member Federation participation of athletes in those ESC Challenge events is free of charge.**

### Payment of Entry Fees

Payments are to be made only in EURO: bank transfer in advance (amounts must be net of any bank spending), and cash payments on arrival at the Registration office for the rest of payments.

### Accreditation Process

All persons involved in the Championship (Athletes, Team Officials, ESC/ISSF Officials, OC Officials, Media Persons) must have accreditations that clearly identify the accreditation holder in order to use the local transportation and to enter controlled areas on the shooting range.

Accreditations (for persons registered before the Late Entry Deadline and with photograph in the ISSF database) will be prepared by the Organizing Committee. All other accreditations will be prepared by the ECH Accreditation Office.

Accreditations and BIB Numbers will be distributed by the Organizing Committee after payment of the entry fees.

## 6. IMMIGRATION AND CUSTOMS REQUIREMENTS

### Entry Visa

Croatia is a member of the European Union.

EU Nationals are able to enter Croatia with a valid passport or with a valid ID Card.

Countries that require an Entry Visa for Croatia should apply to the Croatian Embassy/Consulate in their Country of residence well in advance before departure.

Those Federations who need a specific Invitation Letter to apply for a Sport Visa, must contact the Organizing Committee, not later than **1 JAN 2025** on e-mail: [competition.osijek@gmail.com](mailto:competition.osijek@gmail.com)

The Croatian Shooting Federation and the O.C. has no influence on the Embassies and will only be able to provide invitations for the period of the European Championship and eventual pre-event training.

No Visa will be granted upon arrival at the airport.

## Customs Formalities, Import of Weapons

When entering Croatia, you will need to have an invitation letter and claim possession of the firearms (present an official firearms owners' certificate) to the police officer when crossing the border.

- Persons with an EU firearm permits just have to show the EU firearms permit to the police officer and do not need to show any other forms or pay any taxes.
- Persons arriving from outside the EU or don't have an EU firearm permits, will get an official form from the police when crossing the border, on which they can register up-to three weapons.

Police will issue papers for these firearms, which you must show at departure during check-in and to the police officers.

The tax of 9 EUR is requested for every submitted form.

**Upon arrival** to Croatia all firearms and ammunition must be transported directly to the Shooting range firearms storage.

**At departure** the firearms and ammunition have to be collected from the firearms storage on the way to airport (not before).

**There is no need to send any firearms forms to the OC.**

## 7. OFFICIAL HOTEL / ACCOMMODATION

### Official Hotels

Osijek is the city with many small hotels and our plan is to use 2 or 3 hotels with 4\* about 20 to 35 km outside from Osijek. We assembled the hotels into four (4) categories.

Accommodation will be offered at the following prices, per room per night, breakfast and tax included.

*Although the booking will be based on the principle "first come, first served" (teams making the reservation and transferring 80% of the deposit sooner, will have the privilege to choose), due to the fact that Osijek has a large number of small hotels, the organizer retains the right to perform the optimal booking to avoid accommodating the members of the same team in different hotels.*

Preliminary Hotel Reservations (annex 1.6) must be submitted by: **31 DEC 2024**  
Final Hotel Reservations (annex 6) must be submitted by: **15 JAN 2025**  
The Final hotel Rooming list (annex 6.1) must be submitted by: **25 JAN 2025**

A 80% deposit **upon receipt of the pro-forma invoice but not later than 15 JAN 2025** is mandatory.

Reservations will not be guaranteed unless a deposit of 80% is received by the set deadline. The rest of 20% for accommodation costs must be paid not later than: **5 FEB 2025**.

All bank fees are at the participants' expense.

Any change or cancellation must be notified to the Organizing Committee **not** to the hotels.

#### **Penalty Fees for Cancellation**

- 50% penalty of the total cost till **10 FEB 2025** for any reserved and cancelled rooms
- 100% penalty of the total cost from **10 FEB 2025** onwards for any reserved and cancelled rooms, late arrivals, or early departures

**NO penalty for cancellation will be charged for the hotels in case the Organizing Committee can replace the cancelled reservations with others**

#### **Food Service at the Shooting Range**

LOC will provide a lunch (catering service) at the range with 20,00 € per meal.

### **8. TRAVEL AND TRANSPORTATION**

The Organizing Committee will provide the transport service for all the delegations between the official airports and the official hotels during the official days of the 2024 European Championship.

The official airports are:

1. Airport OSIJEK CRO
2. Airport ZAGREB CRO
3. Airport BUDAPEST HUN
4. Airport BELGRADE SRB

The transportation from and to the Airport „KLISA“ - Osijek is free of charge.

The transportation from and to the Airports: Zagreb, Budapest and Belgrade will be charged 135 € per person (both ways).

The pick-up service at these airports is only for those who are in official hotels.

The Organizing Committee will also provide local transportation daily between the official hotels and the shooting range, according to the official transport schedule.

The transport service will be effective from **March 1 till March 13, 2025**.

**No assistance or transportation will be provided to the participants lodged in unofficial hotels.**

The Delegations deciding to arrive before **1 MAR 2025 or leave after 13 MAR 2025** will have to make their own transfer arrangements, otherwise, on request, the Organizing Committee will organize assistance and/or transportation at the Delegation's expense.

**All transportation services requested in the “Final Travel Form”, not cancelled within three (3) days before arrival, will be applicable by the Organizing Committee according to the number of passengers appearing in the “Final Travel Form” for which the service has been required.**

## **9. COMPETITION RELATED PROCEDURES**

### **Technical Meeting**

The Technical Meetings will take place at the Finals hall on 08.13.2025.

Each participating ESC Member Federation is kindly requested to have at least one representative present at the Technical Meeting to receive updated information regarding Final Competition and Training Schedules and other important issues related to the Championships.

The time of the meeting will be confirmed after the Final Entry Deadline.

### **Storage of Weapons**

Weapons Storage is available at the armory on the shooting range.

It will be opened each day from 07:00 to the 30 min after the end of last event this day.

### **Doping Control Tests**

Doping Controls Tests will be conducted in accordance with the actual ISSF Anti-Doping Rules.

## **10. CEREMONIES**

### **Opening and Closing Ceremony**

Opening will be just after the Technical Meeting.

### **Victory Ceremony**

The Victory Ceremonies will take place at the Finals Hall immediately after the end of each Finals (see also: Final Competition Schedule).

During the ceremonies the athletes are required to present themselves in their official national uniform or national tracksuits (tops and bottoms).
